Listing Syndication: Depending on the instructions that are set by each DR®/Broker Owner, vour listing is then automatically distributed to Realtor.com, MoveInMichigan. com, IDX websites, and more through our syndication program.

Important Notes:

- The Days on Market (DOM) calculation is based on the number of days that occur from the list date to the first day the listing is taken off-market. If re-listed within 30 days, the DOM calculation continues.
- The listing will stay Active until it is changed to another status or expires (at midnight) of the expiration date. All active listings must be avail**able for showings.** Once expired, a listing cannot be extended. It can always be relisted under another MLS number though.
- At 120 days after the Pending date, the MLS system will remind the listing agent to update the listing. This will occur at 180 days for Short Sale or New Construction istings.
